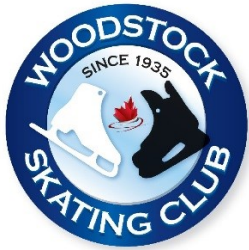

Mission Statement

About the Board

- Up to 15 volunteer members who invest time, energy and commitment toward fulfilling our Mission Statement.
- The Board meets once per month for approximately 2 - 2.5 hours (currently 3rd Wednesday 6:30 - 8:30 pm).
- Board members are expected to also participate as Chair of a Committee where their skills are best suited e.g. Fundraising, Convenor, Membership/Registration, Arena, etc. (see Job Descriptions attached).
- Board members are key advocates for the Woodstock Skating Club (WSC) and participate regularly in special events, fundraising, etc. as ambassadors to promote our Mission Statement.

Expectations

Fulfill a 3-year term as a director while meeting the following expectations:

- To interpret the WSC's work and values to the community, represent the organization in a professional manner, and act as an ambassador.
- Attend 80% or more of Board meetings.
- Become a member of at least one Board Committee and be an active member of such.
- Attend fundraising events, Club events, annual meetings and show support for the WSC as often as possible.
- To act in the best interests of the Club and excuse yourself from discussions and votes where a conflict of interest may be evident.
- To provide input into Club operations, and to take responsibility for making decisions on issues, policies and other board matters.
- To work in good faith with staff and other board members as partners towards achievement of our goals.
